1st joint association-foundation meeting adopts reforms

The alumni foundation and the alumni association held their first formal joint business meeting during the 16th convention and reunion on August 4, 2004 at the Downtown Marriott Hotel in Chicago. Led by their respective leaders, Drs. Bayani Elma, chairman, and Conrado Miranda IV, president of the foundation and Joseph Rastrollo, outgoing president of the association, the twin alumni bodies clarified each other's role vis-à-vis fundraising, donations, co-sponsorship of chapter and reunion activities.

The groups also formalized 4 important collaborative policy moves which would improve their operations and management such as: 1) attainment of permanent tax-exempt status for the foundation in the states of New York, Illinois, and Texas, all sites of past and future conventions; 2) acceptance of Mastercard and Visa credit cards which will provide alumni and donors with a convenient way to pay their membership dues, registration fees, and donations or pledges; 3) approval of a lockbox system for each organization to collect and deposit funds through Lakeside Bank in Chicago, a move that would provide a permanent address and ensure security, accessibility and transparency in the handling of money; and 4) the involvement of a financial or investment adviser in the

both non-profit entities using the expertise of H & R Block.

These were initiated by the association's Vice-President Susan Perez-Suntay, Executive Director Irene Ibanez-Manlapaz with authorizations from Drs. Rastrollo, Miranda, and incoming alumni president Dr. Manny Blas.

Also at the meeting's morning session, a new fund campaign using whole life insurance for charitable giving was launched. The plan to be handled by Farmers Insurance called for a donor to buy a whole life policy making the foundation its beneficiary in which the premium, now treated as a gift

Class '03 scores 72% passing

Proving that class valedictorian Karen Nielsen's (last August board's topnotcher) feat was not a fluke, the UERMMMC Dr. Nie Class 2003 February examinees scored a 72% passing and landed 4 in the top 20, up

from August's 56%.



They were among the 1,084 out of 1,990 (54%) successful candidates who hurdled the week-long physician licensure exams given in Manila and Cebu last month. Results were published in major dailies in the country and their online editions on February 23.

In a news flash to Aesculapius Ex from her office on February 28, Dean Georgina T. Paredes announced that the school's bets grabbed the 9th, 10th, 14th, and 20th spots in the honor roll. is paid by the donor to the foundation which in turn pays the insurance company the structured premium.

So far, the program is yet to catch fire as only a dozen alumni mostly officers, have signed up. Foundation leaders remain optimistic about eventual support from alumni donors after a big push by both organizations and the Farmers Insurance Group at the Chicago convention.

New batch of trustees elected

The early afternoon session of the annual meeting tackled the reports of officers and committees (see pages 6-8) and elected the new batch of five trustees who will serve for a term of three years...

There was one surprise during the election, the decision of Dr. Samuel Dona not to seek another term, thus creating a second vacancy up for grabs. The first one was created by the Dr. Nely Recano's decision months before to step down after serving two terms including a stint as treasurer until 2002. So did Dr. Dona who had served as audit committee chairman. Both expressed the desire, in the words of Dr. Recano, to give "younger members a chance to participate and be active and bring new and fresh ideas to the foundation."

Voted in to replace them were Drs. Irene Ibanez-Manlapaz and Ruby Reyes. Elected with them were returning trustees Drs. Conrado Miranda, IV, Elmer Gilo, and Dekiam Ong.

Manlapaz, association executive director, returns to the board after a year

a year hiatus. She had served one term earlier until 2003. Dr. Reves of Class '78 is the newest member of the board. She did her residency in med-peds and fellowship in allergy and immunology at the UMDNJ-NJ Medical School in Newark where she served as clinical faculty until 2000. She is currently in private practice in New Brunswick, NJ.

All five were immediately sworn in at the meeting by Dean Georgina T. Paredes, herself an ex officio member of the board, attending her first annual meeting.

All current officers of the board retained their positions while minor changes were made in the committee assignments (see roster in pages 10-11).

Every year 5 trustees are elected for a fresh term of 3 years. The Board of Trustees has 15 members in all. The ones whose term is up in August are: Mrs. Amuerfina T. Castro, Drs. Victoria Camacho, Roy Baldomero, Rolando Mendoza, and Renato Querubin.

\$156,00 budget approved

Buoyed by the success of the New York convention in 2003, the board approved a budget proposed by the chairman and president of \$155,561 for fiscal year 2004-2005, a \$73,311 (88%) increase over the previous year's. It calls for near doubling of expenses for current project programs particularly scholarship, faculty development, and library. It is also funding the new projects of drug assistance for indigent patients at the charity hospital at the behest of the alumni association and the dean's special honors award for freshmen. Details of the budget are found in pages 10.

Association's DAP fund now \$162,000

The alumni association set fundraising records as the final figures from the New York and Chicago conventions showed net profits that enabled it to set aside a large sum for the drug assistance program/indigent patient fund project it had officially adopted in 2003.

Under the leadership of then President Joseph Rastrollo and policy implementation by Executive Director Irene Manlapaz, the association saw the need to fund this project to provide UERM medical students with sufficient patients to learn clinical medicine from and offer the community an affordable quality medical care. Current President Manny Blas and President-Elect Edgar Banez also strongly support the project. So have the chapters and their leaders.

In all, the association has donated \$150,776 to the alumni foundation for this project, \$127,776 of which is from the national and past reunion hosts Northeast and Midwest Chapters, \$25,000 from the Southern California, and \$5,000 from the MarVaDC Chapters. Individual alumni donors have also pitched in a total of \$8,000 plus Class '75's \$4,154.81. The total DAP fund so far is \$161,930.81, Dr. Gilo confirmed.

As a result, Dr. Blas decided to go ahead with the first funding release to the UERM Charity Hospital. The mechanics of this are being worked out. The original plan was to build up the

Alumni fund med student's Netherlands stint

Through the alumni foundation, they gave Dumlao \$1,000 for his living expenses for his one month stay in Europe starting last January 24th. UERMMMC defrayed the cost of his plane fare. Those who responded to this urgent call and chipped in the needed amount were: Chuck Gotardo '72 (\$100), Ed Banez '76 (\$100), Benjie Rigor '62 (100), Irene Manlapaz '75 (\$100), Susan Suntay '77 (\$100), and Southern California Chapter (\$500). Dumlao expressed his gratitude in a letter to alumni on page 12.

Freshman scholars adopted

Two appeals for scholarship support published in the alumni association newsletter last June were promptly answered. The Dallasbased North Texas Association of Philippine Physicians led by Dr. Dolores Corpuz Bauzon '65 and previously led by Drs. Asuncion Agustines Acosta '70 and Mike Alday '69, adopted Ms. Mildeanna de Guzman of Dagupan City. The UERMMMCMAAA led by Dr. Joseph Rastrollo '73 took Ms. Melanie Estolas of Pasay City. Both scholars are cum laude graduates from U.P. Manila. Both organizations will give \$1,000 a year to each of them for 4 years until they graduate. The association already remitted its 4-year funding for Estolas to the alumni foundation during the Chicago convention. Dean Paredes continues to appeal for alumni support so she can recruit more top premed graduates to enroll at UERMMMC. See related article on pages 5 & 18.

SoCal raffle winner opts for cash, donates back \$2,000 to chapter

Active missioners: Southern California to Zambales, Northeast to many more places

January and February were busy months for medical missions. The Southern California Chapter team headed by Andy Ebilane and President-Elect Ed Banez went to Iba, Zambales in late January while the Northeast Chapter covered a very wide area. Missioners first participated in the 3rd dermatological mission to Banaue, Ifugao on January 3-5 headed by Dr. Ida Tiongco '68 and hosted by Dr. Tony Ligot '68 of the Good News Clinic and Hospital in collaboration with other groups in the Northeast and the Philippine Dermatological Society. The group reported seeing 500 patients and doing 100 procedures.

The second sortie led by new President Fely David Quines '68 and past head Alex Bobila '73 started with a medical-surgical mission at the UERM Charity Hospital on February 16-18, followed by a similar mission to Banaue on February 20-23 and capped by a humanitarian mission in Zamboanga later in the month

New med school with UERMMMC connection

The AMA Harvard International Medical School opened its doors in Makati last June, 2004 under the academic leadership of many UERM alumni, former Dean Esperanza Lansang told the editor last summer. The

new school is owned by the brother of UERM alum Dr. Sonny Aguiluz '66. The AMA Educational System is known for its computer schools all over the country and Bahrain. Lansang added that she had helped in the school's preparation for accreditation as it would also use the PBL curriculum now in place at UERM. The initial cost for students is P80,000 per semester.

Clerkship in a U.S. hospital inked

The UERMMMC recently signed an agreement with Dr. Sheldon Sirota, Director of Medical Education at St. John's Episcopal Hospital South Shore in Far Rockaway, New York to accept 10 qualified 4th year UERM students into the clinical clerkship in surgery, internal medicine and ob-gyn for the school year 2005-2006. This has been made possible through the help of Dr. Gilbert Makabali '68, chairman of the surgical department and assistant director of medical education at the said hospital. Dean Paredes wrote "The intention of this clerkship affiliation is to give these Filipino-American or American students an early opportunity to be familiar with and gain experience in the U.S. health care system. It will also give them the opportunity to establish ties with residency positions in the U.S. hopefully improving their chances of being admitted to residency training programs."

During her trip to the U.S. last summer, Paredes also began ironing out clerkship affiliations with Jackson Park Hospital in Chicago as well as another one in Rhode Island also with assistance from alumni. No formal arrangements have so far been concluded with either one.

Midwest Chapter donates \$25,000 for scholarship

The dean reported that an agreement was signed on January 17, 2005 between UERM and Dr. Manny Blas,

Facing facts and challenges

"We make a living by what we get but we make a life by what we give." Norman MacEwan



I will follow Jay Leno's lead (host of NBC's *Tonight Show*) by announcing at this date that I will not seek the chairmanship of the foundation come 2006. To paraphrase the late Johnny Carson, "I also have an ego but I do not need to be chairman of the foundation to stoke it." I've found out also that if you let someone else take the credit, you can get results.

To all officers and members of the Board of Trustees and all concerned alumni, the Leadership Workshop and Annual Business Meeting of the foundation will be held on Thursday, August 4, 2005, not the usual Wednesday, at the JW Marriott on Westheimer by the Galleria in Houston, Texas. This wise and practical recommendation came from the most awarded UERM alumnus, Dr. Benjamin M. Rigor: if the 20 officers and members of the BOT would donate the costs of the one-day stay at the hotel alone by checking in a day later, the foundation would be richer by no less than \$2,000 much needed dollars.

The UERM College of Nursing, according to a published report by the

Commission on Higher Education (CHED), is only one of 12 (1 of 5 in MetroManila) out of 175 schools offering nursing programs in the Philippines to get at least 90% of their graduates to pass the yearly board exams from 2000 to 2004. With this stellar record, no wonder the College of Nursing has increased its total enrollment from 613 for SY 2003-2004 to 842 for 2004-2005. In comparison, the College of Medicine's total student population decreased from 994 for SY 2003-2004 to 868 for 2004-2005. The multistory building currently under construction behind the gym will accommodate this burgeoning number of future nurses. Want to hazard a guess or two to explain the discrepancy between the passing rates of the two colleges? They breathe the same air and drink the same water! How about the quality of students being admitted as freshmen? This fact might be a wake-up call for ALL alumni to donate more for scholarshipship programs spearheaded by the alumni foundation and association. The tuition and other fees for SY 2005-2006 for first year amount to P74,288 (\$1,375) per semester. According to Mr. P.O. Domingo whom I met on February 17 in his office, this is the main reason why UE Main students graduating with honors choose to enroll at other medical schools than UERM. Except for U.P. and the Pamantasan ng Lungsod ng Maynila, the fees at the UERM College of Medicine are competitive with other private schools like St. Luke's, San Beda, and MCU. UST, I'm told, charges P100,000 per semester! Mr. Domingo made a very good suggestion: "How about each class from 1961 to 2004 or 43 classes donating \$1,000 to the scholarship program?"

I was stimulated to obtain these foregoing facts about foundations when an alumnus quipped that the assets of OUR foundation have "appreciably grown." In 1975, 21,877 U.S. foundations with assets of \$30 billion gave away \$1.9 B. By 2000, 56,582 foundations gave away \$27.5 B from assets of \$486 billion. Our foundation is small potatoes compared with these giants. But a gift of a dollar, \$100, or even \$1,000 can compete with

Minutes of the 2004 annual meeting

The meeting on August 4, 2004 at the Chicago Downtown Marriott Hotel consisted of three segments: an orientation and leadership workshop; the annual meeting itself; and a joint conference with the alumni association and the auxiliary (Alliance & Friends, Inc.).

The first segment (morning) had two parts. The first was orientation featuring talks on the history of the alumni foundation by Dr. Frank Rabadam, history of the UERMMMC Alliance & Friends by Mrs. Esther Querubin, complimentary relationship among the foundation, association, & auxiliary by Dr. Conrad Miranda, history of the alumni association in the US by Dr. Rogelio Sion, "The Role of the UERM College of Medicine in Meeting the Mission & Objectives of the Alumni Foundation" by Dean Georgina T. Paredes, and recycling for charity by Dr. Benjamin Rigor. The 2nd part was a workshop on management featuring talks on charitable giving through a whole life insurance by Kenneth More, use of a lockbox for fund deposits by Lakeside Bank officers Raymond Spaeth & Todd Monte, and "The Role of a Financial Advisor in Managing the Funds of a Non-Profit Organization" by Michael Sprenger of H&R Block.

The second segment early in the afternoon was the annual meeting. Called to order by the chairman. After establishing a quorum, previous minutes were approved. Under old business, officers' and committee reports were heard, discussed and approved. The chairman gave his report in magazine format. The treasurer reported net worth of \$429,478 as of 2003 (no liabilities). Under new business, the following were done:

(1) elected by acclamation Drs. Conrad Miranda, Elmer Gilo, Dekiam Ong, Irene Manlapaz, & Ruby Reyes for the 2004-2007 term; (2) awarded plaques for distinguished service to

the foundation to Drs. Joseph Rastrollo, alumni president, association Alexis Bobila, Northeast Chapter president, Renato Querubin, immediate past association president, and Nely Recano, immediate past treasurer of the alumni foundation; (3) tabled proposed changes in the bylaws; (4) voted to have a foundation winter meeting;

95) scrapped the scheduled Saturday meeting and opted to hold pre-convention meetings on Wednesdays in the future; (6) decided to purchase a bond for the treasurer; (7) engaged the services of an investment adviser Michael Sprenger of H&R Block to help the investment committee grow the foundation funds; (8) voted to allocate 30% of the new budget for scholarship and require trustees to contribute at least \$100 for scholarship &/or restricted funds and to help in more aggressive fundraising; and finally, (9) approved the 2004-2005 budget.

The joint conference late in the afternoon resolved the following: (1) the alumni association is in charge of the wish list project but donations to it must be payable to the alumni foundation which acknowledges them in writing, the foundation, in turn, disburses funds only after a completed written request or proposal has been received; (2) checks generated from the CME, souvenir journal, wish list and memorial lectures must be made payable to the foundation while proceeds from the gala dinner/dance, welcome reception, and sports tournament go to the association; donations from drug companies could go to either organization depending on a particular company's policies. The business & manner of conducting annual meetings and conventions will be further threshed out by the executive committees of both bodies with legal help.

fund up to at least \$300,000 and then, through wise investment, use only its earnings to fund the drug and laboratory expenses of charity patients at UERMMH. But the dire need of the medical students for clinical materials has impressed the association leadership to advance its distribution to as early as the coming school year or as soon as the legal requirements of such a program are worked out between the association and foundation and the foundation and UERMMMC. The proposed budget of the foundation already calls for an expenditure of about \$72,000 for this purpose.

Meanwhile, the alumni foundation continues to pursue its

Constitution & By Laws

(Third installment, amended on July 30, 2003



ARTICLE VI Officers

Section 1. Election. The election of officers shall be held every two years during the annual meeting or at any adjournment thereof. The Board shall elect a Chairman, Vice-Chairman, President, Vice-President, Secretary, Treasurer, Assistant Secretary, and Recording Secretary. Any such office not filed at the annual meeting or adjournment thereof may bee filled by the Board at any meeting. The Board may at any meeting by resolution elect and define the duties of such officers as it may from time to time determine. No officer, other than the Chairman of the Board, need be a trustee. The same person may be elected to more than one office, except the offices of President and Secretary shall not be held by the same person. A vacancy in any office may be filled by the Board at any meeting. All officers shall hold office at the pleasure of the Board or until their respective successors shall have been elected and shall have qualified. They shall receive such salaries or other compensation as my be authorized by the Board.

Section 2. Resignation and Removal. Any officer may resign at any time by delivering a written resignation to the President or Secretary of the Corporation. The acceptance of any such resignation unless required by the terms thereof, shall not be necessary to make the same effective. Any officer may be removed at any time for or without cause by vote of the trustees.

ARTICLE VII Duties of Officers

<u>Section 1. Chairman of the Board.</u> The Chairman of the Board shall preside at meetings of the Board, shall be a member <u>ex officio</u> of all committees, and shall have such other duties as may be prescribed by the Board.

<u>Section 2. Vice-Chairman.</u> The Vice-Chairman will perform the functions of the Chairman during his absence. He/She will perform other duties assigned by the Chairman.

Section 3. President. The President shall be the chief executive officer of the Corporation and shall have general supervision over the business of the Corporation and over its several officers, subject however, to the control of the Board. Except as otherwise hereinafter provided by these Bylaws, or by resolution duly adopted at any meeting of the Board, the President shall power to sign for the Corporation all deeds and other agreements and formal instruments and shall be a member ex officio of all committees. In the absence or disability of the President, the Vice-President (or, if there be more than one, the Vice-Presidents, in the order of their appointment) shall have the powers and perform the duties of the President. In the absence or disability of the President and the Vice-President (or, if there be more than one, each Vice-President), a trustee of the Corporation may be appointed by the Board to discharge the President's functions in whole or in part, as the Board may specify.

Section 4. Secretary. The Secretary shall take and keep the true minutes of all meetings of the Board and of committees of the Corporation, shall have custody of the corporate seal, and shall have the authority to affix the same to any instrument requiring it, and when so affixed, to attest it. The Secretary shall notify trustees of their election, shall, under the general direction of the President, prepare and present the business to be acted upon at meetings of the Board and of Committees; shall in general perform all duties incident to the office of Secretary; and shall perform such other duties as may be assigned by the Board or the President. In the absence or disability of the Secretary, any Assistant Secretary shall have the powers and perform the duties of the Secretary.

Section 5. Treasurer. The Treasurer shall in general perform all duties incident to the office of Treasurer; the Treasurer shall have the custody of the funds and securities of the Corporation, shall keep full and accurate accounts of receipts and disbursements in books belonging to the Corporation; shall exhibit such books of accounts and records at the office of the Corporation to any of the trustees at any time upon request and shall render a detailed statement to the trustees as often as they shall require it; shall deposit the funds of the Corporation in such banks or trust companies or in such vault or vaults as may from time to time be designated by the Board. Te withdrawal of such funds and securities shall be made only on the signature or signatures of such one or more trustees, officers or employees of the Corporation as may be designated from time to time by the Board for such purpose.

The Treasurer shall perform such other duties as from time to time may be assigned by the Board. The Treasurer, if required so to do by the Board, shall give a bond for the faithful discharge of the Treasurer's duties in such sum, and with such sureties, as the Board shall require. The expense of any such bond shall be paid by the Corporation.

in the absence of the Treasurer, any Assistant Treasurer shall have the powers and perform the duties of the Treasurer.

<u>Section 6. Qualifications of Officers.</u> The nominees should have participated in the activities of the Foundation/alumni Association for at least two years. The qualified nominee shall submit a resume and a signed consent that he/she is willing to serve if elected. The documents shall be submitted three months prior to the Foundation's annual meeting (July/August).

It is not necessary that a nominee be a medical alumni. Other community leaders who could be assets to the Foundation could also be elected as officers and members of the Board of Trustees.

ARTICLE VIII Fiscal Year

The Corporation's fiscal year shall be the calendar year.

Exploring fundraising options

Are the officers and members of the Alumni Foundation fulfilling their promises?

Several months ago, emails from a "Ruben Silang" and an "Al Tanglaw" floated around the alumni cyber circle. The letters expounded on the inefficiency to the point of absurdity of the management of the money of the foundation and the projects that it has been supporting these past few years. The Foundation is now more than 20 years old and one wonders if its leadership needs more time to grow up or do we need new blood with fresh ideas so that the next 20 years or so would be our golden years?

Most non-profit foundations invite volunteers to join their boards because of their expertise or stature in the community that can lead to more donations. Board members and officers usually are required to do fundraising or donate their time and money. In the case of our

Foundation, unfortunately, the recent audit done by Chairman Dr. Bayani Elma has shown that many trustees and officers fail either role. Should we then let alumni as a whole elect the people who are willing to do fundraising or have the Foundation set such a policy? Should we set term limits for trustees and officers so we will have a constant infusion of new ideas and energy that will make the Alumni Foundation stronger and free from a perception of being "passe" or "redundant?"

Further reflection on these matters have led me to believe that either some officers and BOTs do not really have time for the foundation, in which case they should give up their positions for those who have the time, energy and passion to do their jobs, or they do not know what fundraising activities they could do.

One simple and practical way to raise

funds is for officers and trustees to buy the Modified Whole Life Insurance Plan launched in Chicago. This costs about \$26 to \$55 a month depending on age and sex. The monthly premium is immediately tax-deductible to the donor. The equity over time as well as death benefit will be available to the foundation that receives the premium and pays it to the insurer. Encouraging family and friends to join in could net the foundation millions in due time.

What other fundraising projects can we do? How about a fall or winter cruise to the Caribbean, Mexican Riviera, Bahamas or Panama Canal where the weather is warm and the fun endless? With few hours of CME activities, the trip could be tax-deductible. Cruise lines give incentives to tour operators and pharmaceutical companies still sponsor CMEs. Somebody just must find the time to organize the trip!

Elma calls for May board meeting

In an email message on Easter Sunday, Dr. Bayani Elma called for a preconvention business meeting of the Board of Trustees on May 28, 2005 at the Hampton Inn BWI Airport in Baltimore, Maryland, to consider, among others, new requests for funding. The memo also calls for a "wide open" agenda for the afternoon segment of the meeting. The funding requests total \$18,259. About 25% of which is already covered by the budget approved last August. Among the new ones submitted to Elma during his trip to UERMMMC last month are: \$2,400 stipend for a neuro-ophthalmology fellow; \$2,100 stipend for an OB-GYN ultrasound fellow; \$1,040 travel grant for a faculty to present a paper at a meeting in Seoul, Korea in October; \$700 for 2 faculty members to train in skills lab at the University of Hongkong in August; \$1,000 travel grant for a student to present a research paper at the Students' International Forum in June; and a \$1,000 increase in the research & publication award already funded by the alumni foundation.



2PM to 4 PM: Attended the Academic Council Meeting chaired by Dr. Divinagacia and composed of Dean Paredes, Dean Arnel Malaya of Physical Therapy, VPAA & Research & Educational Development Head Dr. Fernando Sanchez, Registrar Genereso Magdaleno, VERM Corporate Treasurer and Secretary. Most relevant information I learned were: clinical clerkship for VERM students are St. John's Episcopal South Shore in New York beginning April, 2005; and a Memorandum of Agreement had been signed between Fairleigh Dickinson University

and VERM for the masteral degree education of nursing, P.T. and engineering faculty from VE Main possibly beginning in SY 2005-2006. Dr. Divinagracia strongly advocated the revival of the Alumni Relations Office to enhance and facilitate inter-alumni and alumni-administration relationships.

Wednesday, February 16, 2005 - 1 Noon to 4 PM: Meeting with Dean Paredes and her staff. There are 800-900 applicants to the College of Medicine and the Admissions Committee has already decided on whom to accept for the first class of 2005-2006. The Recipient Acknowledgement of Funds for the 2 checks for Ms. Estolas's scholarship and the medical library were presented to me. We went over the liquidation reports from the OB-GYN for the books and simulator; psychiatry, biochemistry and ophthalmology for the monies donated by the foundation. We discussed at length her requests for funds for the following: Special Honors Awards for 15 students for SY 2005-2006 (instead of 10), Basic Life Support Skills Lab Project, Student Development Grant, Faculty Development and PD Heads and Travel Grant for Dr. Grace Brizuela's attendance to AMEA 2005. She also requested if the foundation can support one full scholar for 5 years for a total amount of \$6,800 for SY 2005-2006 assuming the student can maintain the academic requirements.

I had a brief meeting with Aesculapian editor Ms. Janice Abadilla who agreed to publish n its quarterly issues any announcements or news about the foundation.

4 PM to 5 PM: Meeting with Mr. P.O. Domingo, Chairman of the VERMMMC Board of Trustees. Also present were Dean Paredes, Drs. Alex & Debbie Bobila, and Irene I. Manlapaz. Dr. Domingo lamented the relegation of the VE College of Medicine to the 4th choice of medical school applicants behind VP, VST, and PLM. He defended a 5% increase in tuition to raise the salaries of faculty and administration which he admitted to be lower than those of VE Recto. He stated that he has not received any salary for the 16 years he has been at the helm of VERM. He pointed out that scholarships at VERM should be defined more clearly" and further challenged that

"each graduating class from 1961 to 2004" should support one scholar."

As a group we thanked him for his valuable time with us and invited him to the Houston convention in August as our special guest, to which he politely declined because he is "too old to travel."



Thursday, February 17, 2005 - 4PM to 5 PM: Meeting with Dr. Sonia Castro-Rodriguez, Chair of the Department of Psychiatry. She said that there are currently 12 in-patients at the psychiatry ward and the staff of 2 residents of the 3-year program sees about 15 outpatients a day. She showed me the documents on how her department has spent the \$4,200 donated by the foundation: Zaguirre Memorial Lectures, 3 journal subscriptions, books and financial support for the psychiatry team that did "critical incident stress debriefing" of the mudslide victims in Real, Quezon recently. She proudly informed that the VERM Department of Psychiatry is the only one in the country to have held yearly postgraduate courses in psychiatry around the country since 1992. She also wanted everyone to now that "VERM has produced the most number of psychiatrits in the Philippines and abroad." From my encounter with this regal lady psychiatrist, I am very pleased that she is the chairwoman of OUR Department of Pscyhiatry!



Adopt a scholar

When I first interviewed Dean Georgina T. Paredes at her office last June, I sensed immediately that she had a clear game plan for the medical school: lead it to academic excellence by recruiting top pre-med graduates and emphasizing faculty development. To this end, her initial foray into alumni affairs in Chicago emphasized scholarship. In that interview, she presented me with a list of 15 desirable applicants for first year most of whom did not have sufficient means to afford enrollment at UERM. Knowing the limitation of our resources, she made an urgent appeal for just two *cum laude* prospects. Alumni responded warmly and took the 2 scholars for four-year funding.


Now, she is out there again searching for similar quality applicants for the incoming class of 2009. This time, she wants more support from alumni. Working with Dr. Elma of the foundation and Dr. Blas of the association, she has refined the alumni scholarship program for freshmen (see pages 5, 12-13) to now involve two categories: (1) scholarship for latin honor freshmen and (2) scholarship for those without latin honors but with high NMAT and GWA.

The first is called Dean's Scholarship which has two levels: gold which grants \$2,000 a year for four years, and silver which gives \$1,000 a year for four years. She wrote me in December that she had already received 7 pledges: 4 from the Midwest Chapter which already remitted \$25,000, one from the Northeast Chapter and two from a couple of classmates.


The second is called Special Honors Award which the foundation has funded starting the 2005-2006 SY, and provides \$365 for each of 10 recipients with GWA of 1.8 to 2.0 and high NMAT score.

She is confident that she can get the best students with our backing. Out of 700 who applied, she hopes to enroll 150 good ones, 15 of whom could be alumni scholars. *Editor*


